LubutoLiteracy Program: Children learn to read most effectively when they are taught in their mother tongues. In partnership with the Ministry of Education, Zambian teachers adapted reading lessons from the Government curriculum in the seven major Zambian languages and talented youth of Lubuto libraries created 100 computer-based reading lessons in each language - 700 lessons in total. The open-source lessons were created on Lubuto's laptops but can be run on any computer platform and will be available to all to download from www.LubutoCollections.org. Through LubutoLiteracy, Lubuto Libraries can actually teach children to read, something not traditionally done by libraries. LubutoLiteracy extends the government reading curriculum beyond the classroom. The Lubuto Library Project initiative was supported by a grant from EIFL in 2010.

Lubuto Mentoring Program: The program, begun in 2010, teaches life skills, builds self esteem and awareness. Over 500 boys and girls participate in each three-month program of weekly sessions, offered year round at Lubuto. The program consists of counseling, mentoring and the teaching of traditional values tailored to the needs of the vulnerable street children that we serve. Many of the children become regular readers at the library and take advantage of other literacy programs offered at Lubuto. Also, dozens of children, who live on the streets, have determined to return to school and the Lubuto staff aids them in this undertaking.

Library Construction: After opening the second Lubuto library in November of 2010, the project furthered their agreement with the Zambian Ministry of Education to build libraries throughout the country. They will be working in direct partnership with the Zambian Library Service to build seven more Lubuto libraries along with the ZLS's provincial libraries, located in each province of Zambia.
